

Augustana / Eksjo LAMP Restructure Meeting Minutes / January 6, 2024 (Approved)

Attending:Interim Pr. Bob Kirchman, Arden Shustad, Marlys Skogmo, John Osborne, Kathy Michaelson, Alex Score, Eksjo

This meeting was held at Eksjo church.

The meeting was opened by Bishop Tesh.

Pr. Kirchman read a short devotion, followed by a prayer.

Bishop Tesh introduced himself and then had all present do the same.

- The purpose of this meeting is to discuss why Eksjo council decided to leave the LAMP parish. Furthermore, the meeting is to discuss if a working relationship could be continued between the two congregations after Eksjo leaves LAMP and what that relationship might look like.
- Eksjo council member, Rob Schwartz spoke about Eksjo's dissatisfaction with the current LAMP agreement. He said there are requirements set forth in the agreement that are not being followed, like council meeting multiple times per year, and therefore the agreement should be changed to reflect what the council is actually doing. He said that Eksjo does not like the way the percentages paid by each congregation is calculated. He said that Eksjo council does not like having two treasurers, one for Eksjo and one for LAMP. (Note: There are actually three treasurers since Augustana congregation also has one). Eksjo council also does not like that the two congregations have equal representation on the LAMP council even though they pay more into the Parish. They feel it would be easier to make decisions and run the finances if the parish was dissolved and a new contractual agreement was arranged. Under this new agreement, Eksjo would hire the Pastor and Augustana would contract for services and Pastoral needs and would pay Eksjo church a set monthly fee for these services. Furthermore, Augustana could make requests, but all decision making would be made by Eksjo's council. This agreement would not be an equal partnership as the current parish is, but rather it would be a contractual arrangement where Augustana would hire services from Eksjo.
- After other Eksjo council members discussed these points further, Augustana members had a chance to speak. John Osborne stated that the Augustana council had decided that they did not have the authority to vote to leave LAMP and that it would take a congregational vote to take such action. He then asked why the Eksjo council had decided they had this authority. Melanie Hanson said that the Eksio council had reviewed the LAMP parish agreement and made a determination that they did not need to have a congregational vote to leave LAMP. Augustana members discussed that they were happy with the current agreement and saw no need for change. They commented that if certain items were not being followed, those particular items should be examined and if so fit, have a vote to change those particular bi laws. They believe the current way to determine percentages is fair, and went on to explain how this formula was initially developed so that there was very little swing from year to year so that each congregation did not have a sudden burden placed on it just because of a one year anomaly in membership or giving. They didn't see the advantage of dropping one treasurer since it would only eliminate one check per month by Eksjo church and have zero effect on Augustana. Augustana members expressed their displeasure with the thought of having no representation in the decision making process, and being subject to the whims of Eksjo. Augustana also said they would want to have a voice on the call committee when a permanent Pastor was called. A comment was made that Augustana had left a contractual agreement to join the LAMP parish, and so if we were going to now be in a contractual agreement and not a Parish with Eksjo, it might serve Augustana better to find a congregation that was in closer proximity to Augustana church to contract with.
- A question was asked by Augustana of Bishop Tesh, if LAMP would need to be dissolved if Eksjo left? The Bishop replied no. Then the Bishop was asked if it were possible for Augustana to keep LAMP and seek other congregations to join us in the Parish? The Bishop replied yes. The question was asked, what would happen to the interim Pastor and the LAMP administrative assistant if LAMP was dissolved? The Bishop said they would both need to be let go from their positions. After this, a call would need to be extended to hire the Interim Pastor, followed by approval from the Synod office, and finally signing a new letter of call. For the administrative assistant position, a normal search and hiring would be completed. After further discussion, Rob stated that the proposal Eksjo had given Augustana was just a starting point and not a take it or leave it offer. It was stated that Eksjo does want to continue a relationship with Augustana. Augustana was encouraged to
- meet and come up with a counter proposal to present to the Eksjo council. Eksjo was asked if they were open to an agreement in which Augustana remained with representation and would have a vote in the decision making process? Rob answered that it might be possible, but probably not an equal vote. He continued, probably something more in line with the payment percentage, maybe one vote for Augustana to three for Eksjo.

Eksjo / Augustana LAMP Restructure Meeting Minutes / January 6, 2024

Present: most Council members from Augustana and Eksjo, LAMP members from both churches, Pastor Bob Kirchman, Bishop Tesh, and Eksjo Youth Director Cole Wixo

Mel Hanson Eksjo President opened with an introduction to tonight's meeting.

Pastor Bob read a devotional from "Inspired" by Rachel Evans, and opened with prayer.

- Bishop Tesh discussed the value in a Parish like LAMP when having numerous churches as it was intended to serve initially and he commented numerous times that a contractual agreement is more common with a 2-point church and he felt that the agreement is not necessary for our 2 churches to operate. The Bishop reiterated that the Synod is there to help where needed and suggested the 2 churches are free to make decisions they see fit to make for the respective churches.
- Members from the churches shared concerns about why this was change was necessary, explanations were provided such as streamlining the process of making decisions, both financially and operational. Concerns were brought up that Augustana could be stuck in a situation that they are not happy with nor have control of, in which Bishop Tesh reminded the group that with any contract there is going to be things are not always going to be perfect and that either party can move on at some point if they aren't happy with the way things are going. Eksjo assured Augustana that it's a priority for us to ensure that Augustana remains happy with the new agreement. Bishop Tesh stated that if Augustana were leave and join another church there would be a contract for them to sign as well, emphasizing that contracts are going to be a part of any agreement between churches.
- The conversation shifted in to the contractual obligations such as things that could be added/amended so that both churches feel represented appropriately. Some of the ideas that could be added to the proposed contract provided to Augustana were adding a "call" provision and providing a representative voice to address concerns that they may not have a say in anything any longer. Eksjo members believe that the equal vote with LAMP is not in line with the financial obligations Eksjo is required to meet. Bishop Tesh encouraged that whatever changes that could be proposed are done in good faith and be reasonable.
- To move things forward: Eksjo has provided a contract to Augustana in November, and Augustana indicated they would discuss this at their annual meeting and begin working on reviewing the contract provided to them with their council then to be shared back with via their contract committee members (TBD) with Eksjo to review, it was agreed upon by both churches to have a check in meeting with both groups **towards the end of February**. The end goal which was also agreed upon by both churches is to **try to have an agreement in place by May 1**st (90 days roughly from Feb 1) or sooner. The meeting concluded on a good note with a lot positivity from both sides hopeful that an agreement can be finalized soon.

The meeting adjourned 7:24 pm after prayer from Bishop Tesh.

From the desk of Pastor Bob Kirchman

Greetings in the Name of Our Lord and Savior Jesus Christ.

* * * * * * * * * * * * * * * * * * *

Like a piece of wood that floats on water, we have been at adrift as an organization. LAMP started with five churches hoping for a level of cooperation and closeness between the ministries of five churches that is rarely, if ever, seen. LAMP went through reorganization almost immediately after being organized. LAMP now has two churches rather than five. With only two churches left, Eksjo and Augustana, the Synod Office believes that a different way of being together is possible. Your long-time pastor, Pastor Roy Noel, indicated the same thing before he left. Members from both churches

believe a different simpler way of the two churches being together is possible.

Currently, Augustana has equal decision-making authority with Eksjo. Augustana contributes between twenty-five and thirty per cent of the cost of LAMP and yet has equal decision-making authority with Eksjo. It is understandable why Augustana likes this arrangement while Eksjo does not. But more importantly, the LAMP board made decisions regarding money when it relied on Eksjo and Augustana to provide the money it wanted to spend. The LAMP's board were dependent on the church councils of Eksjo and Augustana.

The idea is that we replace the current arrangement with a simpler one. Eksjo and Augustana would work together to put together a budget for the common ministry costs. Would the newer arrangement result in Augustana having fewer votes regarding the costs of doing ministry together, yes. Does this mean that Augustana would have to accept whatever Eksjo decided to do? No. It is in the best self-interest of both Eksjo and Augustana to try for consensus about sharing the costs of ministry. Any relationship with any church Augustana enters would unavoidably be one where Augustana has fewer votes than its partner-unless Augustana could pay more of the share of the ministry costs.

I believe it is in the best interests of Augustana to be in partnership with Eksjo. I believe it is in the best interests of Eksjo to remain in partnership with Augustana. We have a history together, we know each other. We have personal relationships with each other. We are used to working together. We make each other stronger. Most people in both churches want to remain together. I know God will be with us as we work through this difficult transition time.

- **Treasurer Report**: \$17,550 ahead of budget. A Tribute in Stone (Headstone lifting co) was paid for the work completed. Youth Director debit card is working (shown as P.O.S. on the bank statement). Discussion about budget items, employment tax / social security for the Youth Director. Motion to approve treasurers report by Daryn, 2nd Travis, motion carried.
- **Pastors Report:** Worship continues to meet and have implemented some subtle things. Further discussion about implementing a TV in the sanctuary to improve worship services and create more options during worship and for events.
- Youth Director Report: Cole wrapped up a busy November with weekly events held (see the full report in the newsletter). He is looking to start a High School bible study, he is working on a location, a pickle ball tournament is planned for January. Progress reports have been issued for confirmands. Cole is working VBS / Campership ideas; he may be sending a survey out. There are a number of children and families that have expressed interest in joining Eksjo, we welcome any and all with open arms.
- **Endowment Committee update**: The endowment fund account is up 12.4% this year, if the year-end was now, there could be approximately \$27,000 that could be used towards the Endowment funding requests. Rob will have year-end totals for the Annual meeting with the final amount that could be distributed though requests that are made.

Old Business:

Oil Rights Attorney Zoom meeting set for January 9th, a reminder will be sent closer to the date.

Light bulbs will be replaced when the electrician can make it out to the church.

LAMP discussion with Augustana, Eksjo and the Bishop will be January 6th at 6:00 pm @ Eksjo.

Cemetery survey tabled until spring.

New Business:

Donation request from DL Rotary for Poles N Holes event of \$100, motion by Janee to approve, 2nd Travis, carried. Grant Application that Lisa created, discussion about it tabled until next month.

Discussion about Pastor stoles and banners for the sanctuary, we only have 1 set, pastor suggested that we have a full set (4x an estimated \$500 each) and Janee suggested adding additional banners. Motion to approve up to \$3,000 for stoles and banners by Rob, 2nd Daryn, carried. Janee / Pastor to work on the options.

Annual meeting set for 1/26/2025.

Motion made to approve the LAMP requested budget of \$110,418.34 made by Rob, 2nd by Travis, carried.

Eksjo budget was set at \$239,078.34, the large increase was due to the Youth Director that was voted on this year which has now been incorporated into the budget. Other notable increases were seen in the insurance for the church, maintenance items. Motion to approve 2025 budget to be presented to the congregation at the annual meeting Rob, 2nd Paul, motion carried.

Discussion about the TV in the sanctuary continued, Cole with work with Kevin Mitchell to get an idea of what all will be needed to implement everything. Janee purchased a 100" TV in preparation for this, motion to approve the purchase of it up to \$2,000. Daryn, Paul, motion carried.

Eksjo Annual Church Meeting Minutes • January 26, 2025 (Unapproved)

Council Vice Chair, Paul Rustad, called the meeting to order at 9:32 am.

Lori Thompson appointed as the secretary for the annual meeting.

- **LAMP Report:** Rob Schwartz provided an update on LAMP. Each church has equal representation on LAMP but Eskjo pays 75% of the budget. An updated contract was drafted to hopefully have an agreement at the end of May. Eskjo offered a two-year agreement. LAMP board has no control over setting the actual budget church. With this agreement, councils will have more involvement with the process. LAMP will be dissolved. And restructured to contractual pastoral services. They will get the same services.
- **Pastor Report:** Pastor Bob is currently an interim pastor, but he would like to remain on. Synod Council called him to be here. Eskjo and Augustana will each have their own separate contract. The call here ends in June. Eskjo has officially given a twelve (12) month notice in December that we are leaving LAMP.

2024 Annual Minutes: Jeff Sanborn motioned to approve the minutes with a 2nd from Rob Schwartz. Carried.

- **Eksjo Budget:** Jeff Sanborn presented the 2025 annual budget. The proposed budget is \$239,078.34. The budget for 2024 was \$155,409.35. We have included the youth director position. We are in good financial standing. We earned \$42,216.29 on the money market. We have 8 or 9 oil wells in North Dakota. We have \$47,723 off of those. We work with attorney Elroy Hanson from Mahnomen, MN. He is the attorney that handled David Larson's estate. Mark is an attorney out of Alexandria, MN that has an expertise in oil fields. He is working with us to ensure that we are maximizing our money gain. Contact Janee with any questions regarding oil. We have put funds down to begin pavement of the parking lot. The price is locked down. Contact Daryn Minske with any questions on the parking lot. Dot Francis and Amy Porter completed the audit this morning. Shirley Rustad motioned to approve the 2025 Annual Budget. 2nd by Ruth.
- WELCA Report: Ruth Lerud is looking for suggestions on events for WELCA. Please contact her with any suggestions.
- **Endowment Report:** Rob Schwartz noted that the money market is doing better. The balance went from \$482,265.94 to \$541,088.43 which was an 12.2% return. The committee had a Zoom call with the broker. Midsummer, the committee moved funds from a conservative account to a higher interest long term account. The endowment fund was created to help the mission of the church and be able to give back. According to the bylaws, we can give 5% of growth. The committee will make recommendations to the council on projects to approve.

Fair Trade: We are serving the fair trade coffee for worship. Please let Joyce know if there is a certain kind you like.

Sunday School, Confirmation, Youth Group and Vacation Bible School: Reported by Cole Wixo

Thank you to Jean Olson, Rachel Johnson, Jean Schartz and Bobbi Chatham for all of their help. The younger kids read a story, have music, and then a skit. Pastor Bob has been writing skits that the 5th and 6th graders perform. The Pre-K love it. Vacation Bible School was a success. We used the same format as last year and it has been working well to combine with other churches. For confirmation, we started with 28 students and now have 32-33 students in confirmation. We have a shared youth group with Lake Park Lutheran and Augustana. We do an event about once per month. All youth are invited. Thank you to the Council for the financial support of the events.

New Business:

A new sign is needed for outside. The weather has taken its toll on the sign.

- There were questions about the potential of a TV for the church. A TV would be placed to the side. The purpose of the TV would be to play videos, music, and the worship service. It would take people to assist with the technology. This would need to be programed weekly. This would also tie to the website. Janee had purchased a 100 inch television, but it was determined it may have been too soon before we have a formal plan in place.
- Kevin Mitchell has assisted us with a new website design. Please send Rob any information you would like added to the website. Kevin has also been assisting with the database for the cemetery. It has not been updated since 2013. Kevin found a widget through a third party. He did add an obituary section.
- Janee would like to purchase new banners for the church. If anyone knows of a company that could make them, please let her know.

We need everyone and all suggestions. Please feel free to lend any talents.
